

DECISION N° 18220276 MINESUP/SG/DAUQ/SDEAC of 13 JUL 2022

To launch the competitive entrance examination into the 3rd year of the *Engineer training course* of the National Advanced School of Engineering of the University of Maroua, and to fix the number of places available for the 2022-2023 academic year.

Mindful of Order 18220053 MINESUP/SG/DAUQ/SDEAC/SE of 16 march 2022 to organize the calendar of competitive entrance examinations into Faculties, Schools and Institutes of Cameroon State Universities for 2022-2023 academic year;
On the proposal of the Rector of the University of Maroua;

DECIDES:

Article 1: A competitive entrance examination for the admission of two hundred and twenty (220) engineers student into the 3th year of **the Engineer training course** of the National Advanced School of Engineering of the University of Maroua for the 2022-2023 academic year.

Article 2 :

(1) The examination shall be organized in one sitting for Cameroonians holders of the Bachelor of Sciences Degree or Diploma required for each course applied, or of the Bachelor of Sciences passed in at least two subjects including the major subjects of the series, the subject "Religious Knowledge" is not taken into consideration. Candidate may also be holders of diploma from a University Institutes of Technology (DUT) or Faculty of Science (DEUG) or any equivalent diploma recognized by the Ministry of Higher Education.

(2) The table below shows the required, Bachelor of Engineering, Bachelor of Sciences required to be qualified to register for the competitive entrance examination:

Article 3:

- (1) Professionals or workers who are successful in the competitive examination must pay a fee for their training.
- (2) Foreign candidates proposed for the training by their government are admitted under the same academic conditions as above depending on the number of places available.

Article 4: The application files shall comprise the following documents:

- A printed application form duly filled in by the candidate on the websites : www.minesup.gov.cm or <http://www.univ-maroua.cm> or <http://www.enspm.univ-maroua.cm>.
- A certified photocopy of the national identity card;
- A certified photocopy of the birth certificate dated not more than three (03) months;
- Transcripts of levels I, II, and III of Bachelor's Degree signed or certified by the competent academic authorities;
- A certified photocopy of the baccalaureate or GCE /AL, or any other diploma recognized equivalent by the Minister of Higher Education, dated not more than three (03) months;

- A certified photocopy of the Bachelor's degree or Bachelor of engineering, or any other diploma recognized equivalent by the Minister of Higher Education, dated not more than three (03) months and gave the right to the competition;
- A medical certificate issued by-a medical Doctor from the Administration testifying that the candidate is physically and medically fit for teaching;
- A Certificate of Non Conviction (bulletin n ° 3) dated not more than three (03) months;
- A receipt of twenty thousand (20,000) CFA as registration fee representing the expenses of exam (payment or transfer fee not included) to be paid into the account of the National Advanced School of Engineering of the University of Maroua, **Account Number 37160230501- 69 issued by COMMERCIAL BANK-CAMEROUN**. Competition fees are not refundable;
- An A4 envelope at the post stamped at 1000 FCFA at the candidate address;
- Four (04) passport-size photographs (4x4);
- Working Candidates should attest their experiences in the field;
- An authorization to sit for the examination from the Heads of Ministerial Departments for civil servants candidates.

Article 5: Holders of foreign diplomas shall submit either the equivalence or the receipt showing that they have applied for the equivalence of their diplomas or certificates issued by the Minister of Higher Education. However, their final admission and the award of a diploma or attestation of completion of the end of their training may be acquired only upon presentation within the time limits set by the competent authority, of the text granting equivalence to their diploma, and obtained from the Minister of Higher Education by the candidate.

Article 6: The Completed application file should be submitted either to the Regional Delegations of the Secondary Education, or to the National Advanced School of Engineering of the University of Maroua, or to the Department of Meteorology, Climatology of the Advanced School of Engineering in Kousseri or to the Antenna of the University of Maroua in Yaoundé, on or before **30 September 2022** at 3,30 p.m. precisely.

Article 7: The competition shall comprise:

- Three written test accounting for 70%
- A scholar appreciation accounting for 30%

Article 8: The written papers will take place on **01 octobre 2022**, in the following examination centers: Douala, Dschang, Garoua, Kousseri, Maroua, Ngaoundéré and Yaoundé.

Article 9:

The programs of the competition are those of the GCA level plus two success year University level. At the end of the written tests and after the registration in the school records, the jury shall publish the list of successful candidates. There is no oral examination.

Admission cannot be deferred for the next or any other academic year.

Article 10: Scholar appreciation is determined according:

- to the age of the candidate;
- the number of years to obtain the Bachelor's degree of 'BAC + 2' ;
- Transcripts of Year I, and II Bachelor's degree of Sciences, Bachelor of Engineering;
