to launch the Competitive Entrance Examination for admission into the **B.Sc. Professional programme in Medical Laboratory Sciences and Nursing** at the Faculty of Health Sciences of the University of Buea and to fix the number of places available for the 2022/2023 academic year.

Mindful of the constitution;
Mindful of law no 005 of 16th April 2001 on the orientation of Higher Education;
Mindful of decree n° 2004/320 of 08th December 2004 to organize the government;
Mindful of decree n° 2004/322 of 08th December 2004 to appoint the members of government;
Mindful of decree n° 2005/142 of 29th April 2005 to organize the Ministry of Higher Education;
Mindful of decree n° 92/074 of 13th April 1992 to transform the Buea and Ngaoundere University Centres into Universities;
Mindful of decree n° 93/034 of 19 January 1993 to organize the University of Buea;
Mindful of decree n° 2017/318 of 27th June 2017 to appoint the Vice-Chancellor of the University of Buea;
Mindful of decree n° 93/027 of 19th January 1993 to lay down provisions common to all Universities, modified and completed by decree no 2005/342 of 10th September 2005;
Mindful of order no.22/18220053/ MINESUP/SG/DAUQ/SDEAC of 16th March 2022 stipulating the calendar of activities for competitive entrance examinations into State Universities in Cameroon for the 2022-2023 academic year;

On the Proposal of the Vice-Chancellor of the University of Buea;

HEREBY DECIDES AS FOLLOWS:

Article 1: The Entrance Examination for the admission of **Sixty (60)** students into the **first year** of each of the Professional Bachelor of Science degree programmes in Medical Laboratory Sciences (MLS) and Nursing (NUS) at the Faculty of Health Sciences of the University of Buea for the 2022/2023 academic year will take place on **Wednesday 28th September 2022** at the campus of the Faculty of Health Sciences, University of Buea.

Article 2: The Entrance Examination into the Professional Bachelor of Science degree programme in Medical Laboratory Sciences and Nursing in the Faculty of Health Sciences is open to all Cameroonian candidates who are holders of:



- a) For the Bachelor of Medical Laboratory Sciences Programme:
 - the G.C.E. Advanced Level in at least two relevant subjects, two of which must be Biology and Chemistry (Food and Nutrition exempted) and the G.C.E. Ordinary Level in five subjects in one session including English Language and Mathematics (Religious Knowledge exempted);
 - the Baccalauréat and Probatoire certificates series C or D;
 - the Laboratory Technician's certificate and the GCE ordinary level passed in five papers (English Language, Biology, and Mathematics inclusive) and at least two GCE Advances Level papers one of which must be Biology.
- b) For the Bachelor of Nursing Science Programme:
 - the G.C.E. Advanced Level in at least two relevant subjects, two of which must be Biology and Chemistry (Food and Nutrition exempted) and the G.C.E. Ordinary Level in five subjects in one session including English Language and Mathematics (Religious Knowledge exempted);
 - the Baccalauréat and Probatoire certificates series C or D;
 - the State Registered Nurse (SRN) Certificate and the GCE ordinary level passed in five papers (English Language, Biology, and Mathematics inclusive) and at least two GCE Advances Level papers one of which must be Biology.
- c) Holders of equivalent qualifications authenticated by the Minister of Higher Education are eligible to apply.

Article 3: The complete application files, which must be received at the Admissions and Records Office of the Faculty of Health Sciences, University of Buea, PO Box. 12 Buea, by **Tuesday 20th September 2022**, and should comprise the following documents:

- a) a filled application form obtainable from the office of the Registrar, University of Buea, upon presentation of a bank receipt of Ten Thousand Francs CFA (10,000 FCFA) addressed to "The Accounting Officer, University of Buea." This sum of money is payable to the following University of Buea bank account: **BICEC Buea Account No. 100010 6842 98394742001-23**. Registration fees are not refundable. The application form is also available on the Web Site of the Ministry of Higher Education, <http://www/minesup.gov.cm>;
- b) a certified-true copy of the birth certificate dated no more than six months;
- c) two (02) recent passport size photographs;
- d) certified-true copies of certificates/diplomas (G.C.E. Ordinary and G.C.E. Advanced Level / Probatoire and Baccalauréat, Laboratory Technician's or State Registered Nurse certificate);

e) certified copies of transcripts (for candidates with the Baccalauréat and Probatoire certificates).

Incomplete files will not be considered.

Article 4: The Entrance Examination will cover topics treated at the G.C.E. Ordinary and G.C.E. Advanced Level / Probatoire and Baccalauréat in the following areas:

-Biology	Coef 3
-Chemistry	Coef 2
-Physics / Nursing	Coef 2
-Use of English	Coef 2
-Oral Examination	Coef 1


The study of the candidate's academic background (quality of certificates and transcripts presented) shall constitute 40% (forty per cent) of the total marks of the Entrance Examination. The written and oral examinations shall carry the remaining 60% (sixty per cent).

Article 5: Eligible candidates for written and oral papers for the Entrance Examination for the Medical Laboratory Sciences and Nursing degree programmes should be on Campus at the Faculty of Health Sciences of the University of Buea at least one hour before the start of the first subject, with their National identity card or valid passport. **No other form of identification will be accepted.**

Article 6: The expenditure resulting from this decision will be charged to the budget of the University of Buea, budgetary charge 620903 for the 2022 financial year.

Article 7: The Vice-Chancellor of the University of Buea, the Director of University Accreditations and Quality, and the Dean of the Faculty of Health Sciences are each entrusted with the implementation of this decision which shall be registered and published in English and French wherever necessary.
