**Article 1:** The public is hereby informed that:

Candidates who are holder of the following diploma/certificates;

that a competitive entrance examination by the study of file (Convention between the four Universities) for the selection of 40 (forty) students into M<sub>1</sub> of the Regional Masters in Integrated Coastal and Marine environment Management of the Institute of Fisheries and Aquatic Sciences for the 2022/2023 academic year is hereby launched only in the **DOUALA** center.

**Article 2:** The Competitive Entrance Examination comprises only a study of files.

**Article 3:** The application files should include the following documents:

- an application form to be filed online at the registration platform address: [www.concours2022.ish.cm](http://www.concours2022.ish.cm);
- a certified true photocopy of the candidate's birth certificate issued not older than 3 months,
- a certified true photocopy of Baccalaureat or GCE-AL ;
- a Certified true photocopy of transcripts of three or six (03 or 06) semesters of the bachelor's degree courses as the case may be ;
- a medical certificate delivered by a State medical doctor, testifying that the candidate is physically fit for university studies;
- a-motivation letter;
- a letter of recommendation ;
- a receipt of payment of the sum of 20,000 CFA francs representing the registration fees ;

In addition to these documents, candidates holding foreign degrees shall attach a copy of equivalence, or an application file to that effect for a certificate comprising the following;

- A stamped application addressed to the Minister of Higher Education specifying the candidate's personal address and phone number abroad ;
- A certified true photocopy of the candidate's birth certificate ;
- A certified true photocopy of the candidate's degree to be evaluated ;
- A detailed and signed Curriculum Studiorum ;
- A certificate of individuality in case the candidate's documents carry different name orders (birth certificate, degrees...) ;
- The exact and complete address of the institution issuing the certificate whose equivalence is requested.

**Article 4:** Registration fees to the competitive entrance examination is the sum of 20,000 CFA francs or thirty five (35) Euros to be paid into the account n° 10033 05214 140160 00004-94 at UBA Code Swift : UNAFCMCX, IBAN: CM21 10033-05214-14016000004-94 of the Institute of Fisheries and Aquatic Sciences of the University of Douala at Yabassi. The registration fees are not reimbursable. It is destined to cover charges generated as the result of the organization of the entrance examination.

**Article 5:** Candidates for the competitive entrance examination into the fourth year should not be more than forty five (45) years old on 1<sup>st</sup> January of the current year.

**Article 6:** Registration for the entrance examination is done on line at the Institute of Fisheries and Aquatic Sciences website address: [www.concours2022.ish.cm](http://www.concours2022.ish.cm). All the required and certified documents must be first scanned and uploaded to the online registration platform. Then, the hard complete application files must reach before the **24<sup>th</sup> of September 2022** in the admissions Office of:


Only candidates who have submitted a complete application file will be considered.
