Concerning the lunch of a competitive entrance examination into the **third year** of the Faculty of Industrial Engineering (FGI) of the University of Douala, and to fix the number of places available for the academic year 2017/2018.

Mindful of law N° 005 of 16 April 2001 on the orientation of Higher Education;
Mindful of decree N°2011/408 of 09 December 2011 to organize the Government ;
Mindful of Decree n° 2011/410 of 09 December 2011 to appoint members of Government ;
Mindful of decree N°2015/434 of 02 October 2015 to reshuffle the Government ;
Mindful of decree N°2012/433 of 01 October 2012 to organize the Ministry of Higher Education ;
Mindful of Decree N° 2015/398 of 15 September 2015 to appoint Rectors in some State Universities;
Mindful Decree N° 2013/0891/PM of 12 March 2013 to appoint staff members at the Ministry of Higher Education;
Mindful of Decree N° 93/026 of 19 January 1993 creating Universities;
Mindful of Decree N° 93/027 of 19 January 1993 to define provisions common to Universities, modified and completed by Decree N°2005/342 of 10 September 2005;
Mindful of Decree N° 93/035 of 19 January 1993 to grant Special Status to the Higher Education Staff ;
Mindful of Decree N° 2015/398 of 15 September 2015 to appoint the Universities Vice Chancellor and Rectors ;
Mindful of Order N° 17/00056/MINESUP/SG/DAUQ/SDEAC/SE of 25 January 2017 to organize the calendar of competitive entrance examinations into Faculties, Schools and Institutions of Cameroon State Universities for 2017-2018 academic year.

ORDERS :

Article 9 : The competitive entrance examination for admission of **seventy (70) students** into the third year of the Faculty of Industrial Engineering of the University of Douala for the 2017/2018 academic year has been launched. Each department will be open to ten (10) students:

- Industrial Construction Technology;
- Hygiene and Industrial Security;
- Industrial Fishery/maritime mechanic;
- Automobile Technology;
- Telecommunication and Information Technology and Communication;
- Civil Engineering;

- Automation.

The competitive entrance examination is going to take place only in the Douala University centre and concern holders of the following certificates:

- a) Scientific degrees (Mathematics, Physics and Chemistry) and students on awaited result may apply;
- b) Diplomas of engineer of works ;
- c) Degrees in technology;
- d) All equivalence diplomas recognized by the Ministry of Higher Education.
- e) Professionals bachelors degree are not allowed

The written examination consists of a main trade paper (Mathematics, Physics, Chemistry and Technology).

Article 2 : There will be no oral exams. Registration is done online at: www.fgi-ud.org

Article 3 : The dossiers of the candidates must contain the following documents:

All complete application files must be deposited at the admissions office of the Faculty of Industrial Engineering (FGI) or at the University of Douala no later than **Tuesday 18th July 2017** and must include the following documents:

An individual registration form to be completed online at www.fgi-ud.org. The completed form shall be printed accompanied by a 1 000 francs fiscal stamp and be signed by the candidate;

1. A certified true photocopy of birth certificate not older than three months;
2. A certified true photocopy of required certificate;
3. A Certified true photocopies of level one, two and three transcripts;
4. A certified true photocopy of “probatoire” or GCE O/L and GCE A/L or “baccalauréat” certificate or slip as the case may be;
5. A medical certificate not older than three (3) months issued by a state medical practitioner testifying that the candidate is fit for higher education;
6. Four (4) recent passport size photographs of the candidate with names written behind.
7. An A4 format self-addressed envelope bearing a 400 francs CFA postal stamp with candidate’s address on it.

Article 4 : The candidates for the competitive entrance examination into the third year must not be more than thirty two (32) years on the 1st of January 1st 2017.


Article 5 : The registration fees for the entrance examination is **Thirty Thousand (30 000) Francs CFA** payable at the **UBA bank Account n° 0 100 500 000 287** of the University of Douala *or through the services of Express Union to the same account in towns where UBA is not present*; against a bank receipt which is obligatory included in candidates’ file of dossiers. **The registration fee is not reimbursable.** It is destined to cover charges generated as the result of the organisation of the entrance examination.

Article 6 : All complete application files must be deposited at the admissions office of the Faculty of Industrial Engineering (FGI) of the University of Douala no later than **Tuesday 18 July 2017**.

Only candidates, who deposit complete application files, will be authorised to write, after a proof of a national identity card duly presented to the invigilator before entering the examination hall.

Article 7 : The written examination will take place on **Saturday 22th July 2017** in the unique centre indicated above **at 8 am**.

Article 8 : The Rector of the University of Douala, Director of the Department of University Accreditations and Quality, and the Dean Faculty of Industrial Engineering (FGI) of the University of Douala are, each in his capacity, responsible for the implementation of this order which shall be registered and published in English and French wherever need be.
