Organising the competitive examination into the first year of the Conception Engineering Cycle (05 years) of the School of Chemical Engineering and Mineral Industries (SCEMI) of the University of Ngaoundéré, and fix the number of places stipulated in the 2020/2021 academic year.

Mindful of the Order N°. 99/003 of 19 January 1993, modifying certain provisions of Decree N°. 79/186 of 17 May 1979 fixing the amount payable as tuition fee;

Mindful of the Decree N°. 2017/402 of 27 June 2017, appointing the Rector of the University of Ngaoundéré;

Mindful of the Order N°. 2017/585 of 24 November 2017 fixing the administrative and academic organisation of the School of Chemical Engineering and Mineral Industries (EGCIM) of the University of Ngaoundéré.

On the proposition of the Rector of the University of Ngaoundéré.

ORDERS:

<u>Article 1</u>: A Competitive entrance examination for admission of **One hundred and sixty** (160) students into the 1st Year of Chemical Engineering (CE), in the training of Conception Engineers in Bio-processes and Chemical Industries at the School of Chemical Engineering and Mineral Industries (SCEMI) of the University of Ngaoundéré for the 2019/2020 academic year shall take place on the **26 September 2020**.

- Article 2: (1) The entrance Examination mentioned in Article 1 above is open to Cameroonians of both sexes as well as to foreigners resident in Cameroon;
- (2) Cameroonians and foreigners presented for admission may be admitted based on the screening of the application file. Nevertheless, the number of places for admission based on the screening of application files shall not exceed 10% of the total number of places available;
- (3) Candidates admitted based on file screening shall pay a tuition fee of One million (1000 000FCFA) each year;
- (4) Candidates admitted out of the CEMAC shall pay a tuition fee of One million (1000 000FCFA) each year.

Article 3: The total number of places offered is One hundred and Sixty (160) places subdivided into different departments as follows:

Article 4: Candidates for the entrance examination shall be holders of any of the following qualifications:

- A Baccalaureat of Secondary Education in any of the series: C, D, E, C1;
- The General Certificate of Education (GCE) Advanced Level obtained with at least 02 out of 04 papers, notably Pure Mathematics, Applied Mathematics, Physics, Chemistry, in addition to four (04) Ordinary Level papers excluding "Religious Knowledge";
- Any other diploma and equivalent qualifications related to the programme that is recognized by the Ministry of Higher Education.

Article 5: The complete application file should comprise of the following documents:

- 1) A completed application form with a 1000FCFA stamp;
- 2) A certified true photocopy of the Birth certficate dated not more than three (03) months old;
- 3) A certified true photocopy of the required diplomas/certificates;
- 4) 04 recent passport- size photographs (4x4) /Quatre photos d'identité (4x4);
- 5) A medical certificate delivered by a certified by health practitioner dated not more than three (03) months;
- 6) A receipt of payment of the sum of twenty thousand (20 000) FCFA being examination fee to EGCIM of NGAOUNDERE delivered by the: SOCIETE GENERALE CAMEROUN, bank Code: 10003, Counter Code: 00900, bank account N°: 22090795734, RIB/code: 25. Deposit may also be done directly in any agency of the SOCIETE GENERALE CAMEROUN bank or

via its partners of the University of Ngaoundéré notably EXPRESS UNION and EXPRESS EXCHANGE;

7) An A4 sized self-addressed and 500 FCFA stamped envelop.

Article 6: Completed application forms are available at and can be deposited on or before Thursday 24 september 2020 at any of the following places:

Article 7: The Entrance examination is based on written tests on the following subjects:

Article 8: The Entrance examination into the First Year of the School of Chemical Engineering and Mineral Industries (EGCIM) of the University of Ngaoundéré is open at the following centres: Ngaoundéré, Dschang, Douala, Maroua, Yaoundé, Buea, Bamenda.

Article 9: The written tests shall take place on the 26 September 2020 at the centres as indicated in Article 8.

Article 10: A communiqué of the Rector of the University of Ngaoundéré shall precise as needs so desire, for each examination centre, the place and the organization of the written tests.

Article 11: Candidates are required to present themselves to the examination centres at least one hour (01H) before the start of the first subject. They must come along with their National Identity Card or any other authentic identification document.

Article 12: The programme for this entrance examination is that high school/upper 6th class/terminales C, D, E, CI and G.C.E. A-Level.

Article 13: Following the proclamation of the results, successful candidates have fifteen (15) days, from the day of effective commencement of classes to present themselves in order to complete registration formalities. Beyond this dateline, absentees would be considered as having deserted and would be replaced by those on the waiting list in the order of merit, by the decision of the Minister of Higher Education, on proposition of the Rector of the University of Ngaoundere.

Article 14: The Rector of the University of Ngaoundere, the Director of the Department of University Accreditations and Quality, and the Director of SCEMI Ngaoundere, are, each in its own right, responsible for the execution of this decision, which has to be enlisted and communicated in French and English.
