To launch the competitive entrance examination into level three of the Engineering Programs of the School of Geology and Mining Engineering of the University of Ngaoundere, for the 2020/2021 academic year.

ARRÊTE :

Article 1: A competitive written examination for admission into level three of the Engineering Programs of the School of Geology and Mining Engineering of the University of Ngaoundere has been launched, for the 2020/2021 academic year, in the following departments and specialties, and in accordance with the number of places available listed below:

- <u>Article 2</u>: (1) The competitive entrance examination is organized in a single session for Cameroonians of both sexes and who are holders of the following certificates:
 - Works Engineer degree or Design Engineer degree;
 - Bachelor's degree in Earth Science, Mathematics, Computer Sciences, Physics, Chemistry;
 - Professional Bachelor's degree in Mining, Petroleum, Gas or Environmental Engineering, in Industrial Security, in Industrial Chemistry, in Computer Studies;
 - any other diploma/certificate recognized by the Minister of Higher Education as equivalent or in exemption
- (2) Candidates who are holders of foreign diplomas/certificates have to present the order granting equivalence issued by the Minister of Higher Education, or the acceptance slip for a diploma equivalence application. However, where the case arises, their final admission shall be possible only on the presentation of proof of having obtained the equivalence of the required diploma/certificate within the date limits specified by the competent authority.
- <u>Article 3</u>: (1) Foreign candidates from member countries of the Economic and Monetary Community of Central Africa (EMCCA) having ratified the texts relating to national treatment of students may be authorized to sit for the examination under the same academic conditions and based on the number of places available, in accordance with the regulation in force.
- (2) Foreign candidates from non member countries of EMCCA and those from member countries who do not sit for the competitive written examination may be selected by study of files and based on the number of places available, if they are beneficiaries of a scholarship from their governments or from a national or international organization which pledges to pay the tuition fees relating to their status.
- (3) Candidates sitting for the competitive entrance examination into level three of the engineering program must not be more than **thirty one** (31) years old as from 1st January 2020.

Article 4: Candidates' files shall comprise all of the following documents:

- an application form to sit for the examination, to be filled and fiscal stamped at the rate of 1000 FCFA by the candidate, to be collected from the School of Geology and Mining Engineering (SGME) at Meiganga (Admissions, statistics, diplomas and certification office), the Rectorate of the University of Ngaoundere, the branch of the University of Ngaoundere at Nkolbisson-Yaounde, the Ministry of Higher Education (Department of University Accreditations and Quality) and the regional delegations for Secondary Education, and downloadable from the MINESUP Internet website (http://www.minesup.gov.cm);
- a certified true photocopy of birth certificate, dated not more*than three (03) months ago, signed by the competent authority;
- photocopies of results transcripts of levels 1, 2 and 3, dated, signed or certified by the head of establishment having issued the originals;
- a certified true photocopy of the required diploma, or an equivalent diploma/certificate recognized by the Ministry of Higher Education, dated not more

- than three (03) months ago, or a Success Testimonial signed or certified by the competent head of establishment.
- a medical certificate issued by a medical doctor working with the Administration, dated not more than three (03) months ago, testifying that the candidate is physically and mentally apt to work as an engineer. Notably that he/she has no physiological impairments especially concerning speech, hearing, sight or movement;
- a certificate of non-conviction (bulletin n°3) dated not more than three (03) months ago;
- a receipt showing payment of the sum of twenty thousands (20 000) CFA francs as examination fees in the EGEM Ngaoundere account, issued by ECOBANK-CAMEROUN, Bank Code: 10029, Counter Code: 26017, Bank Account No: 01215583101, RIB Code: 34, EGEM, Ngaoundere. No other mode of payment shall be accepted;
- four (04) recent passport size (4x4) photographs of the candidate ;
- an A4 size envelope bearing postal stamps respecting current rates (500 FCFA) and carrying the exact address and phone/WhatsApp number of the candidate;
- an A3 size envelope not bearing stamp;
- a proof of having obtained the equivalence of/exemption of the required diploma/certificate or the acceptance slip for a diploma equivalence application as concerns any other foreign diploma.
- Article 5: (1) The examination fees for the competitive entrance examination amount to twenty thousands (20 000) CFA francs to be paid at the bank ECOBANK-CAMEROUN, Bank Code: 10029, Counter Code: 26017, Bank Account No: 01215583101, RIB Code: 34, EGEM, Ngaoundere. The deposit may also be done directly in an ECOBANK-CAMEROUN Agency or via the partners of the University of Ngaoundere notably EXPRESS EXCHANGE and EXPRESS UNION.
- (2) Candidates selected by study of files have to pay tuition fees amounting to **one (01) million CFA francs**, in accordance with decree n°93/033 of 19 January 1993, modifying some provisions of decree n°79/186 of 17 May 1979 to state the payable amount of tuition fees.
- Article 6: (1) Complete files shall be submitted either at the regional delegations for Secondary Education or at the School of Geology and Mining Engineering (SGME) at Meiganga (Admissions, statistics, diplomas and certification office) or at the secretariat of the Rector of the University of Ngaoundere, P.O.B. 454 Ngaoundere or at the branch of the University of Ngaoundere at Nkolbisson-Yaounde or at the Ministry of Higher Education (Department of University Accreditations and Quality) latest friday 18th September 2020.
- (2) Only candidates having submitted a complete regulatory file shall be authorized to sit for the examination.
- <u>Article 7</u>: The written examination shall be conducted on <u>Thursday 24th September 2020</u> in the following centers: <u>Bafoussam</u>, <u>Bamenda</u>, <u>Douala</u>, <u>Maroua</u>, <u>Ngaoundere and Yaounde</u>.
- Article 8: (1) The paper for the written examination is based on the following subjects for all the specialties:

- (2) The paper of the written examination has a mark range from zero (0) to twenty (20).
- Article 9: (1) After due deliberation by the jury, the jury shall establish, according to specialty and in order of merit, the tentative list of candidates for final admission.
- (2) The candidate's performance in the written examination or in the final admission cannot be carried forward from one academic year to another.
 - (3) The final results shall be published by the Minister of Higher Education.
- (4) Fraudulent admission following failure to enforce the required condition for diploma, grade or age exposes the candidate concerned to automatic expulsion at any time without any due form and procedure.
- <u>Article 10</u>: The composition of the jury cited in article 9 above shall be established in a special text by the Minister of Higher Education in accordance with the regulation in force.
- Article 11: The examination fees mentioned in article 5 above are non-refundable.

Article 12: The Rector of the University of Ngaoundere, the Director of University Accreditations and Quality and the Director of the School of Geology and Mining Engineering are, each in his sphere, charged with the implementation of this order which shall be registered, published according to the procedure of urgency and inserted in the Official Gazette in English and French.
