To launch the Competitive Entrance Examination into **Third Year of the First Cycle** of the Higher Technical Teacher Training College (HTTTC) of The University of Bamenda at **Bambili**, and to fix the number of places available for the **2020/2021** academic year.

- Mindful of Decree N°2018/191 of 02nd March 2018 to reshuffle the Government;
- Mindful of Decree N° 2019/002 of 04 January 2019 to reshuffle the Government ;
- Mindful of Decree n°2012/433 of October 1, 2012, to organise the Ministry of Higher Education;
- Mindful of Decree n° 2010/372 of December 14, 2010, upgrading ENSAB into Higher Teacher Training College (HTTC) and Higher Technical Teacher Training College (HTTTC);
- Mindful of Decree n° 004/CAB/PM of February 10, 2000, on admission into national schools of training and recruitment of civil servants;
- Mindful of Decree n° 2010/371 of December 14, 2010, creating the University of Bamenda;
- Mindful of Decree n° 2011/045 of March 08, 2011, to organise the University of Bamenda;
- Mindful of Decree n° 2015/541 of November 27, 2015, appointing the Vice Chancellor of the University of Bamenda;
- Mindful of Decree n° 2018/074 of January 29, 2018, appointing the Director of Higher Technical Teacher Training College Bambili;
- Mindful of Order n° 20-00407/ MINESUP/SG/DAUQ/SDEAC/SE of 26th May 2020 modifying order n° 20-00106/MINESUP/SG/DAUQ/SDEAC/SE of 17th March 2020 fixing the calendar of competitive examinations into Establishments of Cameroon State Universities for the 2020-2021 academic year,

ORDERS:

Article 1: A Competitive Entrance Examination into **year three of the first cycle** of the Higher Technical Teacher Training College (HTTTC) of the University of Bamenda at **Bambili**, for the **2020/2021** academic year has been launched in the following Departments:

ARTICLE 2: Admission into the Third Year of the First Cycle of HTTTC for 2020/2021 is launched with the following conditions.

(i) AGE LIMIT

Admission into the third year of the HTTTC is open to Cameroonians of both sexes not more than **thirty one (31)** years on January 1, 2020. The age limit does not apply to civil servants.

(ii) REQUIRED CERTIFICATES

Candidates must be holders of the following certificates:

BTS, HPD, DUT or HND delivered by the Minister of State, Minister of Higher Education, for the following specialty: , Electrotechnics, Mechanical Manufacturing, Fashion Clothing and Textile, Home Economics, Fundamental Computer Sciences, Accountancy, Management, Marketing. **Holders of the DUT must also hold the Baccalaureat, the "Brevet de Technicien" or the GCE Advanced Level in their speciality.**

(iii) Holders of DIPET I, DIPES I are not eligible

Article 3 The entrance examination is opened only to holders of the required diplomas at the time of application.

Article 4 The registration procedure and file shall consist of the following:

- An online application form to be filled at the web address <http://www.htttcuniba-edu.cm/entrance> by the candidate;
- Download and print out the application form and the acceptance slip;
- Present yourself at any **Express Exchange SA** branch nationwide with the online application form for payment ;
- Obtain a receipt upon payment of twenty thousand (20,000) CFA as registration fee delivered by **Express Exchange SA**. No other form of payment shall be accepted;
- for payment ;
- A certified true photocopy of the birth certificate dated not more than three (3) months;
- Transcripts of Probatoire or GCE A/L (lower and upper sixth transcripts) or Baccalauréat signed or certified by the competent academic authorities;
- A certified photocopy of GCE O/L or Probatoire , GCE A/L or Baccalauréat or equivalent diploma dated not more than six (6) months.
- Transcripts of first year, second year of studies for holders of HND/BTS/DSEP/HPD or levels first, second and third years of studies for holders of bachelor's Degrees/BT/DUT signed or certified by the competent academic authorities;
- A medical certificate issued by a state medical doctor
- A certificate of non-conviction dated not more than three months;
- One self-addressed A4 envelope bearing postal stamps in conformity with the regulations in force;
- Two passport-size photographs;
- An authorisation to sit for the examination issued by the Minister of Basic Education, the Minister of Secondary Education, the Minister of State, Minister of Higher Education for candidates working in those Ministries, or the Minister of Public Service for other civil servants.

Article 5 (1) Holders of foreign diplomas shall submit either the equivalence or the receipt showing that they applied for the equivalence of their diplomas or certificates. The order granting equivalence and the receipt are issued by the Minister of State, Minister of Higher Education.

(2) The final admission of these candidates shall be confirmed only on presentation within the date limit set by the competent authorities of the text granting them equivalence.

Article 6 Complete files should be submitted to HTTTC Bambili campus or the Regional Delegations of the Ministry of Secondary Education latest on **Friday, October 9, 2020**. An official shall sign the acceptance slip and return to candidate for safe keeping

Article 7 (1) the examination shall comprise:

- a. A major and minor paper based on Multiple Choice Questions (70% of the total assessment);
- b. Study of files (30% of the total assessment);

Article 8 The written papers based on Multiple Choice Questions will take place on Saturday, October 24, 2019, at 02 p.m., in the following examination centers: Bafoussam, Bambili, Buea, Douala, Ngaoundere and Yaounde.

(2) The syllabuses of the competitive entrance examination are the same as that of HND/BTS/DSEP/HPD/BT /DUT bachelor's Degrees programs.

Article 10 (1) Marks for the written papers ranged from zero to 100. Any candidate who scores less than 25/10 shall be disqualified.

(2) The study of files assessments will mostly be based on:

- the candidate's age;
- the number of years spent in Secondary and Higher Education ;
- the grades of GCE O/L and GCE A/L certificates and the average marks of Probatoire and Baccalauréat

Article 11 The final results shall be published by the Minister of State, Minister of Higher Education after deliberations by a constituted jury.

Article 12. The composition of the jury mentioned in Article 11 above will be the prerogative of the Minister of State, Minister of Higher Education,

Article 13 The registration fee as stipulated In Article 4 above is nonrefundable.

Article 14 The Vice-Chancellor of The University of Bamenda, the Director of University Accreditations and Quality and the Director of the Higher Technical Teacher Training College Bambili, each in his/her own sphere, are responsible for the implementation of this order which shall be registered and published in English and French wherever necessary.
