To launch the competitive entrance examination into the 1<sup>st</sup> year of 1<sup>st</sup> cycle of the Higher Technical Teachers' Training College (HTTTC) of the University of Yaoundé I, and to fix the number of places available for the academic year 2020/2021.

#### **ORDERS:**

#### ARTICLE 1:

1) According to the order n° 20/00407/ MINESUP/SG/DAUQ/SDEAC/SE of Mai 26 2020 amending the order n° 20-00106 MINESUP/SG/DAUG/SDEAC/SE of March 17 fixing the calender of competitive entry examens into states University schools of Cameroon under the supervision of MINESUP, for the academic year 2020/2021, the competitive entrance examinations into 1<sup>st</sup> year of 1<sup>st</sup> cycle of the Higher Technical Teachers' Training College (HTTTC) of the University of Yaoundé 1 for the 2019/2020 academic year shall take place in the following centres: BAFOUSSAM, BERTOUA, BUEA, DOUALA, EBOLOWA, GAROUA, and YAOUNDE for entrance into all levels

### **ARTICLE 2: AGE LIMIT**

The competitive entrance examination is open to Cameroonians of both sexes and of:

- not more than twenty-nine (29) years old on January 1st 2021 for admission into the first year of the 1st cycle through written examination;
- Candidates who are civil servants and who meet every other requirement are not concerned by the age limit.

ARTICLE 4: The competitive entrance examination will be written in two papers: one major (Speciality) and a minor paper (General Knowledge) level Terminale/upper six or GCE A/L of the technical or general education

### **ARTICLE 5: APPLICATION FILES**

Applications for the competitive entrance examinations which must be received at the HTTTC and in Regional Delegations of MINESEC not later than the 30th of september 2020 must include the following documents:

- 1. An online registration and printing of the application form by the candidate from the website www.ensetebolowa.com of The University of Yaounde I.
- 2. Transcripts of Lower and Upper Sixth forms, signed, dated and annotated by the Principal of the School where the original were issued.
- 3. A certified true and legible photocopy of the birth certificate of less than three (3) months old.
- 4. A certified true and legible photocopy of each of the required certificates. Candidates who are holders of Baccalaureate or GCE AL shall add a certified true copy of Probatoire or Ordinary Level.
- 5. A medical certificate of less than three (3) months old, delivered by a medical Doctor of the Public Service, attesting the candidate's fitness to be a teacher according to the rules and regulations in force.
- 6. A certificate of non-conviction of less than three (3) months old.

7. Four (4) passport size pictures of the candidate.

- 8. The payment of a non-refundable application fee of twenty one thousand francs CFA (21000) should be made into the establishment's UBA account in Ebolowa N° 10033-05211-11004-000029-81 or through any of the bank agencies within the country. Any other payment will not be accepted.
- 9. A stamped, self-addressed envelope size 28 x 37.
- 10. An unstamped envelope without address size 28 x 37.
- 11. A document showing that the equivalence has been formally granted for any foreign certificate contained in the candidate's file.

## **ARTICLE 6: CALENDAR**

- 1) The written part of the entrance examinations listed above shall take place on the Wednesday 14<sup>th</sup> October 2020, in all the centres indicated in article 1
- Access to the examination halls will be subject to the presentation by each candidate of his or her national identity card and the receipt for the application fees mentioned in article 5 above.

ARTICLE 7: The registration fees for the competitive entrance examination and the selection for readmission are not refundable.

# **ARTICLE 8: CANDIDATES FOREIGNERS**

Within the limit of available places, foreign applicants who fulfil the requirements stipulated by the rules and regulations in force may also be admitted after the study of their files or through written examination.

<u>Article 9</u>: The Rector of the University of Yaoundé I, the Director of University Accreditations and Quality, the Director of the Higher Technical Teachers' Training College, are each in charge of the execution of the present decision which shall be registered and communicated in French and English where-ever need arises.
