MINDFUL OF Decision n° 20-00407/MINESUP/SG/DAUQ/SDEAC/SE of May 26, 2020 amending the Decision n° 20-00106/MINESUP/SG/DAUQ/SDEAC/SE of March 17, 2020 setting the calendar for competition entry into the Establishments of Cameroon State Universities and Schools under academic supervision of MINESUP, for the academic year 2020 - 2021;

DECIDES AS FOLLOWS:

Article 1: A competitive entrance examination for admission of Two hundred and sixty six (266) students into the first year of the Advanced Professional Studies (EPA) Programme of the Advanced School of Economics and Commerce (ESSEC) of the University of Douala for the 2020/2021 academic year is hereby launched. The training is full-time (day classes). The options and number of places are as follows:

Article 2: The examination is opened to candidates of both sexes, holders of at least a Bachelor Degree or its equivalent.

Article 3: Candidates application files include the following:

- 1) A registration form (obtainable at ESSEC, or at the Department of University Accreditation and Quality at the Ministry of Higher Education; also downloadable online at the url: www.essec-douala.cm/concours2020);

- 3) A certified true copy of birth certificate, not older than three (3) months;
- 4) A certified true copy of Baccalauréat or GCE A/L;
- 5) A certified true copy of the bachelor degree giving right to the examination;
- 6) A schooling certificate testifying that the candidate is registered in a third year Bachelor Degree cycle class, for candidates applying under the reserve of succeeding in their Bachelor degree;
- 7) A medical certificate, not older than three (3) months, issued by a state registered medical practitioner;
- 8) Two (2) recent passport size photographs of the candidate;
- 9) An authorization to register for the competitive examination issued by the Ministry of Public Service and Administrative Reform, or the competent Administrative Authority, for **civil servants and state agents**;
- 10) The receipt issued upon payment of **twenty Townsend (20.000) CFA Francs on the following account : École Supérieure des Sciences Économiques et Commerciales (ESSEC), n° 14004000005, United Bank for Africa (UBA) Cameroon. (NB : the payment should strictly be made under the candidate's name)**;
- 11) An A4 self-addressed envelope bearing a 400 CFA Francs postal Stamp.

Article 4: (1) Once the above file has been constituted, the admission diploma (or the schooling certificate), the certified photocopy of the birth certificate, a passport size photo and the payment receipt must be scanned in color to be deposited on the online registration platform (www.essec-douala.cm/concours2020) after having properly filled all the requested information, **no later than September 23, 2020 at midnight.**

(2) **Only those candidates who will have fulfilled this online registration of their application shall be authorized to sit for the examination.** This requirement also applies to foreign CEMAC candidates and all applicants must note that access to this online registration will no longer be possible after September 23, 2020.

(3) **The complete hard copy file should be deposited at the admission office of ESSEC or sent to ESSEC postal address (BP: 1931 Douala – Cameroun), no later than Friday, September 25, 2020, trusting the post office stamp.**

Article 5: (1) **The competition will take place on Tuesday, September 29, 2020, starting at 08 am sharp,** potentially in the following examination centres: Douala, Yaoundé, Bafoussam, Garoua. To access the examinations rooms, the national identity card will be required to the candidates.

(2) Applicants from centres that will have collected less than 100 applications may be grouped together in a nearby center. As well, centres can also be created in regions with more than 100 applicants. The information relating to this, as well as the examination location, will be indicated on the ESSEC website, one week at the latest before the examination runs.

Article 6: For Cameroonians and non CEMAC nationality candidates, the competitive entrance examination has only one part, a written examination representing 100% of the final mark. Subjects will be available in French and English and it is up to candidates to choose any of both languages.

Article 7: the examination comprise the following two (02) papers of equivalent importance:

1.	Economic ESSAY	on an economic subject to test the candidate's interest in economics or management topics relating to contemporary firms preoccupations, current national and international economic problem or to recent economic history or geography	03 heures
2.	Specialty paper	to test the candidate's aptitude to carry on advanced studies in the chosen option for specialization	03 heures

Article 8: With respect to some communitarian agreements, 10% of the places opened to Cameroonians and non CEMAC nationality candidates are granted on title to foreign candidates who are nationals of the CEMAC zone. These places shall be shared among these countries, based on the criterion of merit, in proportion of the number of candidates originating from each of them.

Article 9: The Rector of the university of Douala, the Director of the Department of University Accreditations and Quality, and the Director of ESSEC, shall be responsible, each in his own sphere, for the implementation of this decision which shall be registered and published wherever necessary.
