To launch the competitive entrance examination into **Level II** of the “Ingenieurs” Programme specializing in Agronomy and Forestry (Campus of Dschang and Campus of Bafia) and into Level II of the Professional School of Wood, Water and Natural Resources (Ebolowa Antenna) of the **Faculty of Agronomy and Agricultural Sciences (FASA)**, of the University of Dschang, and to fix the number of places available for the **2020/2021** academic year.

Mindful of Decree N°2012/433 of 01 October 2012 to organize the Ministry of Higher Education;
Mindful of Decree N° 2015/398 of 15 September 2015 to appoint Rectors in some State Universities;
Mindful of Decree N° 2012/366 of 06 August 2012 appointing Administrative Staff in State Universities;
Mindful of Decree N° 2013/0891/PM of 12 March 2013 to appoint staff members at the Ministry of Higher Education;
Mindful of Order N°20 - 00407/MINESUP/SG/DAUQ/SDEAC of 26 Mai 2020 fixing the calendar of entrance exams for the institutions of Cameroon State Universities and Schools under academic supervision of MINESUP, for the academic year 2020 - 2021,

ORDERS:

Article 1:

- (1) The public is hereby informed that a special competitive entrance examination for the recruitment of **thirty (30)** students into **Level II** of the "Ingénieurs" Programme specializing in Agronomy and Forestry (twenty (20) in Dschang Campus and ten (10) in Bafia Campus), and twenty (**20**) students into **level II** of the Professional School of Wood, Water and Natural Resources (Ebolowa Antenna) of the Faculty of Agronomy and Agricultural Sciences (FASA), of the University of Dschang, for 2020/2021 academic year has been launched with centres at **Bafia, Douala, Dschang, Ebolowa, Ngaoundéré and Yaoundé**.
- (2) For the Programme specializing in Agronomy and Forestry (Dschang and Bafia Campuses), the entrance examination is opened to the holders of:
- a Certificate of Senior Agricultural Technicians, senior Forestry or Agroforestry Technicians with "Baccalauréat" or the General Certificate of Education Advanced level (GCE«A» Level) in at least two scientific subjects;
 - a Scientific DEUG (two years in a Faculty of Science) in Biology, Chemistry, Physics or Environmental Sciences;
 - any other equivalent certificate recognized by the Ministry of Higher Education
- (3) For the Professional School of Wood, Water and Natural Resources (Ebolowa Antenna) of the Faculty of Agronomy and Agricultural Sciences (FASA), the entrance examination is opened to the holders of:
- a Certificate of Senior Agricultural Technicians in Water Science and Engineering, in Wood Technology or Senior Forestry or Agroforestry Technicians or Senior Technicians in Environmental Sciences with "Baccalauréat" or General Certificate of Education Advanced level (GCE«A» Level) in at least two scientific subjects;
 - a scientific DEUG (two years in a Faculty of Science) in Biology, Chemistry, Physics or Environmental Sciences;
 - any other equivalent certificate recognized by the Ministry of Higher Education
- (4) The entrance examination is opened to Cameroonians of both sexes and the citizens of member countries of the Central African Economic and Monetary Union (CEMAC) who have ratified texts on national treatment of students and who are holders of equivalent qualifications.

(5) Candidates from other countries including CEMAC member countries who do not write the entrance examination but hold a scholarship from their Government or International Organization may apply for direct admission, which is contingent upon the number of available places and payment of 1.000.000 (One million) FCFA/year as tuition fees.

(6) The twenty (20) places of the Dschang Campus shall be distributed as follows:

- 15 for those who write the entrance examination, and among them:
 - 10 for holders of the Senior Technicians Certificate;
 - 05 for holders of the DEUG;
- 05 for those applying for direct admission (file study)

- (7) The ten (10) places of the Bafia Campus shall be distributed as follows:

- 08 for those who write the entrance examination, and among them:
 - 05 for holders of the Senior Technicians Certificate;
 - 03 for holders of the DEUG;
- 02 for those applying for direct admission (file study)

- (8) The twenty(20)places of the Ebolowa Campus shall be distributed as follows:

- 15 for those who write the entrance examination, and among them:
 - 10 for holders of the Senior Technicians Certificate;
 - 05 for holders of the DEUG;
- 05 for direct admission (file study).

Article 2:

(2) The program of study is the one being followed in the classes preparing students for certificates required to write the entrance examination.

Article 3: Students awaiting results will be declared definitively admitted or successful, in the case of success of the entrance examination, only upon presentation of the original of the diploma required or, if applicable, upon presentation of success testimonial at the time of registration. **There will be no oral exam.**

Registration shall be done online from the University of Dschang Website SIGES ONLINE at the address: <http://sigesonline.univ-dschang.org>;

Article 4 : Application files include the following documents

1. An application form downloaded following the procedure of online registration from the University Website SIGES ONLINE at the address <http://sigesonline.univ-dschang.org>
2. A certified-true photocopy of birth certificate not more than three months old;
3. A Certified-true photocopy of "Baccalaureate" or GCE-A/L certificate or equivalent certificate, or of the success testimonial of any of these certificates as the case maybe;
4. A certified-true photocopy of certificate of Senior Agricultural or Forestry or Agroforestry Technicians, or certificate of Senior Agricultural in Water Science and Engineering in Wood Technology or Senior Technicians in Environmental Sciences, of certificate of Scientific DEUG, or an equivalent certificate;
5. Curriculum vitae;
6. Certified-true photocopies of transcripts (Level 1 and Level 2);
7. A medical certificate of fitness not older than three months issued by a state medical practitioner testifying that the candidate is fit for higher education;
8. Four (04) recent passport size photographs of the candidate with names written behind;
9. Employer's authorization to write the entrance examination (for applicants earning a salary);
10. A receipt of payment of **25,000 (Twenty-five thousands) FCFA** as application fees issued by **COMMERCIAL BANK- Dschang** at the account N°**37142002005-40**

or by any financial establishment chosen during the online registration process, to be presented during the exam;

11. An A4 size self-addressed envelope bearing a 400 FCFA postal stamp with candidate address on it.

Article 5: The registration fees for the entrance examination is **25,000 (Twenty-five thousands)francs CFA payable to the COMMERCIAL BANK - Dschang account N° 37142002005-40 or in a financial institution chosen during download of the discharge against receipt** (bank receipt should be included in candidate file). The registration fees are not reimbursable. It is destined to cover charges generated as the result of the organization of the entrance examination.

Article 6: All complete application files must be deposited at the admission's service of the Faculty of Agronomy and Agricultural Sciences (FAAS), main campus of Dschang, or in the Antennas or Annex of the University of Dschang in Bafia, Ebolowa, Yaoundé, Maroua, Belabo or Bambui no later than **21st September 2020** at the latest at 15h30mn. The files can also be deposited at the Garoua School of Fauna, at the admission's service of the Faculty of Science of the University of Ngaoundéré, or at the Regional Delegation of Secondary Education of the Littoral in Douala.

Only candidates, who deposit complete application files, will be authorized to write, after a proof of a national identity card duly presented to the invigilator before entering the examination hall.

Article 7: The written examination will take place on **Saturday the 26th September 2020 at 7:30 am** in the centres indicated above

Article 8: The Rector of the University of Dschang, the Director of the Department of University Accreditations and Quality, and the Dean of Faculty of Agronomy and Agricultural Sciences are, each in his capacity, responsible for the implementation of this order which shall be registered and published in English and French wherever need be.
