To launch the competitive entrance examination into the first year of Initial Training at the University Institute of Wood Technology (IUT-BOIS) of the University of Yaounde I at Mbalmayo, and to fix the number of places offered for the 2020/2021 academic year.

On the proposal of the Rector of the University of Yaounde I,

DECIDES:

ARTICLE 1: A competitive entrance examination for the admission of 120 (one hundred and twenty) candidates in the first year of the University Institute of Wood Technology (IUT-BOIS) of the University of Yaounde I at Mbalmayo has been launched in the following fields, for the 2020/2021 academic year:

<u>ARTICLE 2</u>: The competitive entrance examination cited in article 1 above is open to Cameroonian of both sexes and to foreign candidates residing in Cameroon within the limits of available places.

ARTICLE 3: Candidates for the competitive entrance examination should be at most 29 years of age by the date of the examination.

ARTICLE 4: The application file should comprise the following documents:

- 1. An application form;
- 2. A certified true copy of the birth certificate dated not more than three (3) months;
- 3. A Certified true copy of the BT or G.C.E. A/L in Mathematics, Physics, Chemistry;
- A certified true copy of the certificate/diploma qualifying for the competitive entrance examination or a testimonial, if need be;
- 5. Four (4) passport-sized photographs;
- 6. A medical certificate issued by a certified medical doctor dated no more than three (3) months;
- An attestation of payment of the sum of twenty thousand 20.000 CFA Francs into Account N° 10033 05211 11004000009 44, in the name of "INSTITUT UNIVERSITAIRE DE TECHNOLOGIE DU BOIS" at the United Bank of Africa (UBA) or in all the Express Union Branches in Cameroon
- 8. A large self-addressed envelope bearing a 400CFA Francs stamp and the address of the candidate written behind.

ARTICLE 5: The competitive entrance examination will be written on Wednesday 16 September 2020 in the following Centres:

 IUT/BOIS situated at the National School of Forestry (ENEF) at Mbalmayo; IUT Douala, University of Buea, University of Bamenda, Lycée Technique Bertoua, University of Ngaoundere, University of Dschang.

ARTICLE 6: The programme for the competitive entrance examination shall be that of the Upper Sixth and Terminale Classes in the indicated subjects and series. The written papers shall be based on the following subjects:
