Launching competitive entrance examination into the **first year** of **Telecommunications Engineers and Administrators of Posts and Telecommunications** into the National Advanced School of Posts, Telecommunications and Information and Communication Technologies (SUP'PTIC) of Yaounde, for the **2020-2021** academic year.

- Mindful** of decree N° 2016/425 of 26th October 2016 changing the denomination and reorganizing the National Advanced School of Posts and Telecommunications;
- Mindful** of decree n°2017/594 of 04th December 2017 appointing the Director and the deputy Director of the National advanced School of the Posts, Telecommunications and Information and Communication Technologies;
- Mindful** of decree N°2019/002 of 04th January 2019 to reshuffle the Government;
- Mindful** of order N° 20-00407/MINESUP/SG/DAUQ/SDEAC/SE of 26th may 2020, to modify order N° 20-00106/MINESUP/SG/DAUQ/SDEAC/SE of 17th march 2020, organizing the calendar of competitive entrance examinations into Faculties, Schools and institutions of Cameroon State Universities for 2020-2021 academic year;

On the proposal of the Director of the National Advanced School of Posts, Telecommunications and Information and Communication Technologies.

DECIDE:

ARTICLE 1: Competitive entrance examinations for the recruitment in the **first year** of **Telecommunications Engineers and Administrators of Posts and Telecommunications** shall be written on the **08th and 09th October 2020** at the unique centre of Yaounde.

ARTICLE 2: GENERAL CONDITIONS FOR WRITING

celcom

1- Telecommunications Engineers (IT) / Master in Engineering

- Should be male or female, aged 17 at least as from the 1st January 2020;
- Should be holder of Maitrise or Master I in mathematics or physics, Diploma of Assistant Telecommunications Engineers or bachelor degree in Telecommunications, electronics, electricity and computer sciences recognised by the Ministry of Higher Education.

2- Administrators of Posts and Telecommunications (APT) / Master in Administration

- Should be male or female, aged 17 at least as from the 1st January 2020;
- Should be holder of Maitrise or Master I, Diploma of Inspectors of Posts and Telecommunications or bachelor degree in logistic and transport, accounting and finance, marketing, management and administration recognised by the Ministry of Higher Education.

ARTICLE 3: NUMBER OF PLACES

The number of places available per cycle is as follow;

1) Telecommunications Engineers: 50 places

- Direct admission for outstanding students of Assistant Telecommunications Engineers of the **2017-2020 batch: 30 places**
- Entrance examination: **20 places**

2) Administrators of Posts and Telecommunications: 50 places

- Direct admission for outstanding students of Inspectors of Posts and Telecommunications of the **2017-2020 batch: 30 places**
- Entrance examination: **20 places**

ARTICLE 4: CONTENT OF CANDIDATE'S FILE

Candidate's file which must be submitted at the National Advanced School of Posts, Telecommunications and Information and Communication Technologies (SUP'PTIC) of Yaounde, on the **06th October 2020 for the Cameroonian Candidates and 31st October 2020 for the foreign candidates** latest, shall be made up of the following documents:

- An application form duly filled by the candidate on line on the web site entrance examination of the National Advanced School of Posts, Telecommunications and Information and Communication Technologies of Yaounde (www.supptic-cmr.cm)
- A payment receipt to any post office, account number **150657330-19** of **25,000 CFA Frs.**
- A certified true copy of birth certificate not more than 03 months old from the date of certification;
- A certified true copy of the required certificate;
- Transcripts for the last three or four years spent in the University or a Higher Institution;
- A school attendance certificate for candidates still expecting the results of the required certificate;
- A medical certificate of fitness for working in the Posts and telecommunications sector, issued by a public medical practitioner;
- Four passport size photographs (4x4);
- A certified true copy of the National Identity card;
- A self-addressed stamped (Postal Stamp) envelope (500F CFA)
- Eventually the equivalent of the diploma presented.

ARTICLE 8: SCHOOL FEES PER YEAR

Candidates admitted into the school must present the originals of the certificate or diploma and pay the following amounts on the yearly basis.

ARTICLE 9: Examination registration fees are non-refundable.

ARTICLE 10: Only candidates who have submitted a complete and regular file shall be authorised to sit for the examinations.

ARTICLE 11: The results of the examinations shall be published by a communique of the Minister of Higher Education and the Minister of Posts and Telecommunications.

ARTICLE 12: Foreign students shall sit for special examinations organised by the Director of the National Advanced School of Posts Telecommunications and Information and Communication Technologies in collaboration with the concerned countries.

ARTICLE 13: Candidates presented by the public and para-statal and /or private organisations fulfilling the general conditions for the competitive entrance examination shall be authorised to write the exams.

ARTICLE 14: At the end of their training, outstanding students at Master's level will benefit for scholarships at the Doctorate program.

ARTICLE 15: The Director of the National Advanced School of Posts, Telecommunications and Information and Communication Technologies and the Director for University Accreditations and Quality are each in his capacity, responsible for the implementation of this decision, which shall be registered, published and broadcast wherever need be./-
