To launch the Competitive Entrance Examination into the first year of the College of Technology (COT) of the University of Buea and fixing the number of places offered, for the 2021/2022 academic year.

THE MINISTER OF STATE, MINISTER OF HIGHER EDUCATION:

Mindful of the constitution; of law n° 2001/005 of 16th April 2001 on the orientation of Higher Education; Mindful of Decree n° 2011/408 of 09th December 2011 to organize the government; Mindful of Decree nº 2011/410 of 09th December 2011 to appoint members of Government; Mindful of the Decree n°2019/002 of 04 January 2019 to re-shuffle the Governement; Mindful of Decree no 2012/433 of 01st April 2012 to organize the Ministry of Higher Education; Mindful of Decree no 2005/342 of 10th September 2005to modify and complete certain dispositions of decree Mindful n°93/027 of 19th January 1993 to define common dispositions applicable to Universities of Decree nº 92/074 of 13th April 1992 to transform the Buea and Ngaoundere University Centres into Mindful Universities: of Decree no 93/034 of 19th January 1993 to organize the University of Buea; Mindful of Decree No. 2017/318 of 27 June 2017 to appoint the Vice-Chancellor of the University of Buea; Mindful of Decree n° 2012/333 of 29 June 2012 appointing persons in State Universities; Mindful of Decree nº 2012/366 of 06th August 2012 appointing persons in State Universities; Mindful of Decree n° 2013/0891/PM of 12th March 2013 appointing persons in the Ministry of Higher Education; Mindful of Decree no 2014/545 of 10th December 2014 to appoint the Director of the College of Technology; Mindful of order n° 21-00075/MINESUP/SG/DAUQ/SDEAC/SE of 15th February 2021 fixing the calendar of the Mindful competitive entrance examinations into establishments in State Universities and higher institutions under academic supervision of MINESUP for the 2021/2022 academic year; On the proposal of the Vice-Chancellor of the University of Buea

DECIDES AS FOLLOWS:

Article 1: A Competitive Entrance Examination for the selection of two hundred (200) students, for admission into the first year of the Bachelor of Technology degree programme of the College of Technology (COT), of the University of Buea for the 2021/2022 academic year is hereby launched to admit students in the Departments of Computer Engineering, Electrical and Electronic Engineering and Mechanical Engineering on Friday, 10th September 2021.

Article 2: The Competitive Entrance Examination cited in article 1 shall be open to male and female Cameroonians and to foreign candidates resident in Cameroon within the limits of available places.

Article 3: Applicants for the competitive entrance examination must be holders of one of the following qualifications:

- General Certificate of Education Ordinary Level in at least four science subjects; and General Certificate of Education Advanced Level in at least two science subjects.
- Baccalaureat C, D, E, F1, F2, F3 or BT (MSIE, MAV, MEM);
- General Certificate of Education Technical Ordinary and Advanced Level in relevant
- Any other certificates recognized as equivalent by the Ministry of Higher Education;



Article 4: The complete application file must include the following documents:

- 1) An application form to be completed online by the applicant. The application form which is found on the University of Buea website: www.ubuea.cm should be completed no later than Friday, 3rd September 2021. Late or incomplete application files shall be rejected;
- 2) Certified true copy of the candidate's birth certificate not less than three (3) months old;
- 3) Photocopies of the relevant academic certificates indicated in Article 3 above;
- 4) Receipt of payment of CFAF 20,000 (twenty thousand francs) for the examination, payable to the following account at Banque Atlantique Cameroon:

Article 5: All documents mentioned in Article 4: 2), 3), and 4) above should be scanned and emailed to the address cotec@ubuea.cm

<u>Article 6</u>: The examination centres are **Buea**, **Bamenda**, **Douala and Yaounde**. A press release published by the Vice-Chancellor of the University of Buea shall ultimately indicate the modalities of the organization of the written examination.

<u>Article 7</u>: Candidates are requested to come to the examination centres at least 30 minutes before the start of each examination paper. They must come along with their National Identity card.

<u>Article 8</u>: The written papers below will account for 60% and study of files 40%. The written examination is based on the High school syllabus and will comprise:

- Mathematics paper (3 hours, coefficient 4);
- Physics paper (3 hours, coefficient 4);
- Language paper (1 hour, coefficient 1).

Article 9: The Vice-Chancellor of the University of Buea, the Director of University Accreditations and Quality and the Director of the College of Technology of the University of Buea shall be responsible, each in his/her own sphere, for the implementation of this decision which shall be registered and published wherever need be.
