ANNOUNCES:

Article 1 : A recruitment into the the first year of the Brevet de Technicien Supérieur (BTS) is open at the University Institute of Technology (UIT) of the University of Douala for the academic year 2021/2022, in the specialties specified in section 3 below.

Article 2: The recruitment referred to, in article 1 above, is opened to Cameroonians of both sexes and to foreign candidates, and is based on file hearing.

Article 4: The registration is done online at UIT Website www.iut-douala.cm

The complete application file which will be received at the Admission office of the UIT of the University of Douala **6th September 2021 latest** must include the following documents:

- 1) A registration form to be duly **filled online** in the Web site of UIT of Douala: www.iut-douala.cm, printed and signed by the candidate, and stamped at CFAF 1,000. An amount of CFAF 20.000 representing the examination fees must be paid before registering online;
- 2) A certified true **photocopy** of the birth certificate issued within the last three (03) months;
- 3) A certified true copy of one of the diplomas giving right to the examination;
- 4) A medical certificate issued within the last three (03) months by a state medical practitioner and testifying that the candidate is fit for higher education;
- 5) Two (02) recent passport-size photographs of the candidate;
- 6) A **twenty thousand (20 000)** CFA francs banking receipt being examination fees to pay at the **UBA account N° 10033 05214 14004000006 – 90, or the BICEC account N ° 01253101002-18;**
- 7) A **21 x 29.7 size** self-addressed envelope bearing a CFAF 400 postal stamp, bearing the address of the candidate;
- 8) A regular photocopy of the National Identity Card.

Article 5: Successful candidates shall report to UIT for registration formalities within fifteen days following the date of publication of the final results. Candidates, who fail to comply with this requirement, as need arise, shall be replaced by those on the waiting list following the order of merit, through a press release published by the Minister of Higher Education on the recommendation of the Rector of the University of Douala.

Article 6: The Rector of the University of Douala, the Director of University Accreditations and Quality, and the Director of UIT of Douala, each in his own sphere, are responsible for the implementation of the present press release which shall be registered and published in English and in French wherever necessary./-
